THE WARRANTIES AND REMEDIES CONTAINED HEREIN ARE EXCLUSIVE AND IN LIEU OF ALL OTHER WARRANTIES EXPRESS OR IMPLIED OR STATUTORY, INCLUDING ANY LIABILITY ARISING UNDER ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, STATUTORY OR OTHERWISE.

THIS WARRANTY GIVES THE OWNER SPECIFIC LEGAL RIGHTS, WHICH MAY VARY FROM STATE TO STATE. IN NO EVENT SHALL AMI BE LIABLE FOR ANY INCIDENTAL, SPECIAL, INDIRECT OR CONSEQUENTIAL DAMAGES, WHETHER RESULTING FROM THE USE, MISUSE, OR INABILITY TO USE THIS PRODUCT OR FROM DEFECTS IN THIS PRODUCT. Some states/areas do not allow the exclusion on incidental or consequential damages. In those states/areas the duration of this and any warranty is 30 days from original ship date.

AMI retains the right to repair or replace the product or offer a prorated refund of the purchase price at AMI's sole discretion.

SUCH REMEDY SHALL BE THE CUSTOMER'S SOLE AND EXCLUSIVE REMEDY FOR ANY BREACH OF WARRANTY.

This warranty covers original manufacturing and material defects for the lesser of a period of two years from original ship date from AMI or 1 year from first run or 200 hours running time except as reduced above.

The engine must be run within 90 days of shipment or preserved for long term storage. The engine must be subsequently run every 40 days or preserved for long term storage. Failure to preserve for long term storage as required voids the remaining warranty.

This and all other warranties expressed or implied are voided by racing including non-organized racing, competition use of any type, commercial use of any type, physical damage of any type, overheating, detonation, incorrect fuel, incorrect oil, insufficient oil, modifications, extended high power use, operation beyond or outside of manufactures recommendations, over revving, prop strike, environmental effects, corrosion, freezing, installation errors, misuse, abuse and all other similar reasons.

All warranty work is to be performed at AMI's place of business and all shipping and other costs are the sole and exclusive responsibility of the customer.

Such repairs or replacements will be made at no charge to the customer for parts and labor, provided that the customer shall be responsible for any transportation costs to and/or from AMI. AMI will not pay for onboard labor or travel required for this standard limited warranty.

AMI may at times offer other assistance to the customer but at the sole discretion of AMI and this is offered as good will and does not provide any extension or expansion of the warranty. Any work done does not extend the warranty scope or period.
